**WE PROPOSE:**

A contract agent position as Designer Community Manager to contribute to the further development of the New European Bauhaus, in particular to the management of the New European Bauhaus community, including in shaping and managing associated communication channels and tools (Website, social media, apps etc.).

Main tasks will include:

- Mobilise relevant knowledge and experience in the fields of Community building for policy innovation and implementation at EU level;
- Shape and run participatory processes activating the Community, including in the context of the NEB Lab;
- Bring in (design) process management, a missions approach or similar agile project management expertise for the further development of the NEB lab;
- Translate abstract information into concrete visually attractive concepts for the NEB community, e.g. in digital maps, manuals, tools, booklets, websites, etc.;
- Analyse needs from users or stakeholder groups and translate those needs into functional requirements for products that bring people together;
- Shape and manage communication and community management platforms and tools;
- Shape and manage mechanisms and tools to support experience and knowledge sharing across the New European Bauhaus Community;
- Provide contributions to briefing, assistance and support to the Directorate General and/or Cabinet the New European Bauhaus;
- Identify possible partnerships, synergies and opportunities with Commission services as well as with interested stakeholders in Member States to develop and use community development methods and features in support of the New European Bauhaus;
