Deploy Design to create a prosperous Europe.

Foster skills for a prosperous Europe:

Increase and ease funding for design education programmes across Europe to ensure the needed skill set and lifelong learning among design and creative cultural professionals. This will lay the ground for future prosperity. Currently, the Creative Cultural Industry is Europe's third largest GDP provider, where around 3% of the European Union's labour force is employed.

Invest in Design Research:

Increase funding for design research projects that bridge the science – implementation gap, explore future potentials, assess design impact, and address its role in tackling global challenges. This will strengthen Europe's position at the forefront of innovation and its positive effects.

Foster Design Innovation through IP Rights:

Strengthening intellectual property (IP) rights for design, particularly for micro-SMEs and start-ups. This will foster a secure environment for design investment and protect human rights and the creative work of European designers. The infringement of IP Rights and the power structure of content users vs. content creators must be acknowledged. An alternative dispute resolution—handled by a European-wide system of ombudsmen and clearinghouses similar to the Consumer Protection Cooperations—might be a feasible way to handle such disputes before they go to court.

Integrate Design in Procurement:

Establish clear guidelines for public procurement processes that consider design and functionality. This will ensure that public projects are efficient, aesthetically pleasing, user-friendly, and sustainable and decrease bureaucratic processes.

Design for Trade:

Ensure that trade agreements prioritize fair competition for European design products and intellectual property. This will protect European design businesses and promote the value of European design globally.

Strengthen Democracy by re-building Trust and Citizen Engagement with Design Methods

Engage in citizen-centric policymaking:

Embed design methodologies throughout the policymaking process, from conception to implementation. This ensures creative, compelling and user-centred solutions that are effective, efficient, and meet the needs of European citizens and governments.

Create positive social impact:

Allocate funds to design projects that address societal challenges like accessibility, social inclusion, democracy, rural and urban planning, health and well-being. Design creates a more equitable and citizen-friendly environment for all Europeans.

Countermeasures against misinformation and disinformation:

Deploy Design methods and Strategies to support democratic thinking and media training to decrease the potential impact of misinformation and train critical thinking. Additionally, investing in a design-literate population will equip individuals with critical thinking, problem-solving skills, the ability to accept ambiguity, and an understanding of the need and ability for transformation. Thus, we can all support the defense of democracy in the current challenges of systems.

Design Diplomacy:

Develop a comprehensive design strategy to leverage design as a tool for international cooperation and cultural exchange to promote European values.

**Create an ethical AI, just Digital Market and
trust in future developments:**

Support the need for a harmonised European mutual understanding between all European Member states of the AI ACT.

This will positively impact digital innovation processes and potential European unicorns, as European innovations and re-manufacturing depend highly on harmonised understanding and ethically just regulations. The obligation to provide evidence about IP Rights infringement in the training and use of generative AI should be reversed. Content creators of all creative industries (Micro-SMEs and Start-ups) need new and adapted tools to address and dispute infringements arising from AI – such as an Alternative Dispute Resolution through an AI-Ombudsman institution.

**Safeguard and promote public values in the
digital transitions:**

More than ever, we need to take care of the values of a.o. democracy, non-discrimination, data ownership and diversity following our European position between East and West and big tech. *Design is the tool for that.*

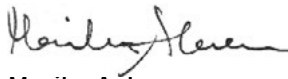
Shape Sustainable Futures:

Support and incentivise using value-driven business models, life-cycle assessment, and eco-design principles. Up to 80% of an artefact's or product's environmentally harmful impact is due to its planning and design phase, whether analogue or digital. 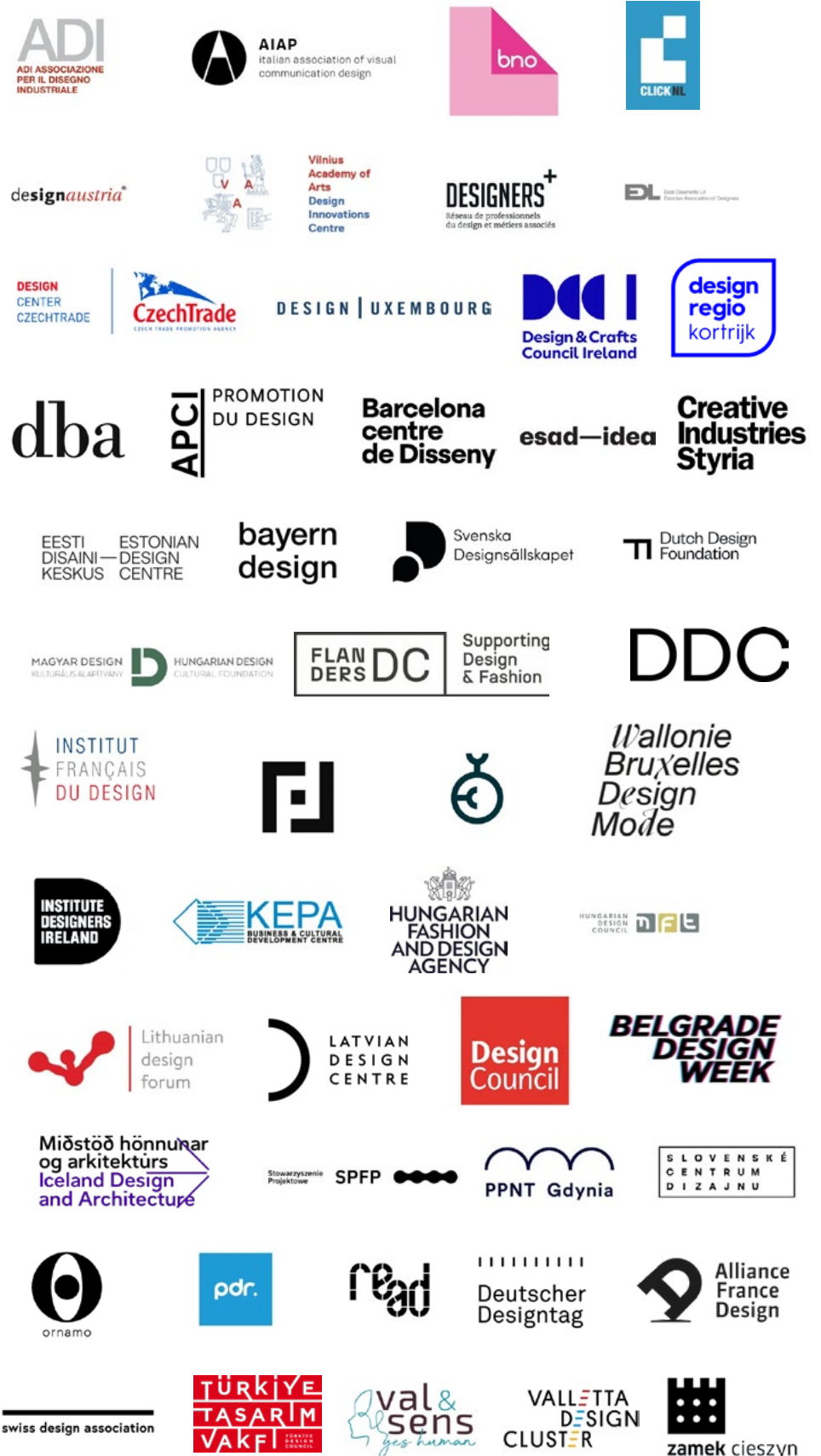
